- **Art.1. Organisation, date and venue:** The business event TSS -Toulouse Space Show 2018 is organized by PROXIMUM s.a.r.l. and it will take place at Pierre Baudis Congress Centre, on June 26th-28th of June 2018. In the event of circumstances beyond his control (referred to as force majeure), the organizer may choose to change the dates or the venue of this event or cancel it after notifying the participants.
- **Art.2. Registration:** Your TSS -Toulouse Space Show 2018 registration will only be effective upon acceptance by the organizer.
- **Art.3. Cancellation:** The contract is concluded and binding. No refund or credit of any kind will be issued.
- **Art.4. Catalogue:** All participants must pay their deposit (100% of the total amount) before the opening of the technical catalogue, in order to have their corporate presentation published in this catalogue.
- **Art.5. Limit of liability:** PROXIMUM as the organizer is bound only by a best efforts obligation.
- **Art.6. Exhibition of equipment:** no materials shall be exhibited by the participants outside or above their allocated booth.
- **Art.7. Booth maintenance:** Each participant commits to assure the maintenance of his booth during its use and should be present on it during the event.
- **Art.8. Insurance:** Each participant will have to provide a proof of insurance covering its legal liability and all damages for which the participant may be held responsible, such as: theft, fire, deterioration, damage or destruction of any equipment or installation. Reciprocally, all participants and their insurers waive all claims against PROXIMUM and its insurers.
- **Art.9. Advertising:** Subsequent to the acceptance of the registration, the organizer authorizes each participant to mention the following sentence on its sales and advertising correspondence: "participant in the B2B event TSS – TOULOUSE SPACE SHOW 2018". Likewise, each participant authorizes PROXIMUM to communicate about his/her attendance to this business event. After acceptance by the organizer, any participant authorizes Proximum to forward its contact details to the organizing partners.
- **Art.10. Confidentiality:** In accordance with the French Data Protection Law of January 6th 1978, all people providing personal information have the right to access, correct and delete this data.
- **Art.11. Jurisdiction clause:** in the event of a dispute, the jurisdiction of Nanterre - France has sole competence.
- **Art.12. Clause on the right of publicity** During the event, a photo and video device will be covering the event in order to create a film and a photo album which could be used in promotional purposes (film-making, usage of photos in the creation of communication documents, website animation...) within the national territory, for a period of 3 years from the moment of the event. Hence, the participants to TOULOUSE SPACE SHOW 2018 entitle PROXIMUM Group and its organizing partners, upon registration to the event, to use their image exclusively within the field of promotion of the events organised by PROXIMUM Group.
- **Art.13.
